Criminal History Check, Driving History Check, Child Abuse Registry Check:

The work of KCSA, Inc. involves responsibilities, which require important safeguards in the public interest. Accordingly, all offers of employment (paid or unpaid), and new Employee/Volunteer status are contingent upon satisfactory reports from law enforcement agencies and, as available, from registries of child abuse offenders, and from the Bureau of Motor Vehicles or other governmental entity from which driving records are available. If a new Employee or Volunteer has lived in another state or community in the last five years, checks may be conducted in that state/community.

The Executive Director may waive the requirement for a driving record check for those applicants who do not qualify for a driver's license for any reason. However, under no circumstance shall these Employees or Volunteers be allowed to operate a motor vehicle while performing any duty for KCSA, Inc.

Any applicant who has been convicted of a crime involving any of the following will not be eligible for employment (paid or voluntary) at Kosciusko County Shelter for Abuse, Inc.:

- any form of abuse or neglect of a child or protected adult
- domestic abuse,
- sexual assault,
- sexual offences of any nature
- assault and/or battery,
- stalking,
- criminal trespass, or
- invasion of privacy
